In the summer of 2003, Terry helped Arnold Schwarzenegger win the historic recall election and become Governor of California. He was appointed as the Secretary of the California Environmental Protection Agency in November, 2003, and Cabinet Secretary, the Chief Policy Advisor to the Governor, in December, 2004. He continues to advise the Governor on energy and environmental policy. In April, 2007, he was named the Cullman Senior Fellow and Director, Climate Policy Program, of the New America Foundation. He currently travels throughout the United States and the world, lecturing and providing private consulting services to a variety of clients, including several Governors and Canadian Premiers on climate and energy policy.

Jeffrey D. Byron, was appointed to the California Energy Commission by Governor Arnold Schwarzenegger in June 2006. Commissioner Byron fills the public-at-large position with over 30 years of experience in the electric power industry and over 10 years of service assisting customers in meeting their energy needs. Commissioner Byron serves as Presiding Member of the Energy Commission's Electricity Committee and as Associate Member on the Siting Committee, the Transportation Committee, the Natural Gas Committee, and the ad hoc committee for the joint greenhouse gas reduction proceeding with the CPUC.

Allen Alley, Deputy Chief of Staff, Governor's Office, State of Oregon



In January 2007, Governor Ted Kulongoski of Oregon appointed Alley his deputy chief of staff, responsible for overseeing the policy areas of economic development, technology, transportation, energy, workforce training, rural policy, housing and minority, women and emerging small businesses. With more than 30 years' experience in a multitude of disciplines, Alley now works to strengthen the bridge between Oregon's public and private sectors. "He is someone...who has a proven record of leadership, innovation, and a commitment to Oregon's future," Kulongoski said at the announcement of Alley's appointment.

The Office of Clean Energy Collaboration's mission is to develop and promote international partnerships for the deployment of emerging technologies related to greenhouse gas abatement and to serve as the Secretariat to the Carbon Sequestration Leadership Forum.

Frank T. Princiotta, Director, Air Pollution Prevention and Control Division, U.S. Environmental Protection Agency



Frank T. Princiotta is the Director of the Air Pollution Prevention and Control Division (APPCD) of the National Risk Management Research Laboratory (NRMRL), Office of Research and Development (ORD), U.S. Environmental Protection Agency (EPA) in Research Triangle Park, North Carolina. He is responsible for research, development and demonstration of methods and technologies for controlling air pollution from stationary sources. Before assuming this position at Research Triangle Park, Mr. Princiotta was Director of the Energy Processes Division in EPA Headquarters in Washington, DC, where he directed EPA efforts to develop and improve technology for controlling pollution associated with the production and use of energy.

Doug Scott, Chair, Illinois Climate Change Advisory Group



Doug Scott was appointed Director of the Illinois Environmental Protection Agency effective July 1, 2005 by Governor Rod Blagojevich. Amongst the many new progressive programs Scott is responsible for are: a brownfields program that is one of the nation's most successful in cleaning up and redeveloping abandoned industrial and commercial sites; continued clean air progress through enlisting citizens and industry and negotiating for huge reductions in emissions from the State's coal-fired power plants, supporting clean coal technology, wind power and other alternative energy and fuel sources; making Illinois the nation's leader in public notification and community relations activities on environmental concerns. Director Scott is now chairing the Governor's Greenhouse Gas Advisory Committee, looking at ways to reduce the impacts of global warming.

Gia Schneider, Vice President, Credit Suisse



Ms. Schneider is a Vice President for Credit Suisse where she manages the bank's carbon marketing and structuring strategy, and relationships with compliance buyers and other investors. Gia has been active in the carbon market since 2005 and sits on the board of the European Climate Investors and Services, which is an industry trade association formed to represent the 'market' perspective on emissions trading and climate investments to policymakers worldwide.
